Sub: Request for lodging F.I.R. against arrested accused person Imran Sk (22yrs) S/o Sk Ibrahim of Village- Baishyakuli, PS- Para, Dist- Purulia.

Sir,

In producing herewith arrested accused person namely Imran Sk (22yrs) S/o Sk Ibrahim of Village- Baishyakuli, PS- Para, Dist- Purulia along with seized one black and purple colour Motor Cycle (Honda Dream Neo) bearing Regd. No- WB 82C/6510, I beg to report that today myself along with force of Para PS were performing Day mobile duty by Govt. vehicle heading towards Mahadebpur to Para pitch road under Para PS area vide Para PS Misc C.C No- 1906/22 dtd 25.07.2022 and Para PS GDE No- 1013 dtd. 25.07.2022. at about 12.05 hrs, I found one black and purple colour Motor Cycle (Honda Dream Neo) bearing Regd. No- WB 82C/6510 coming from Anara side rashly and negligently. We tried to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to the local public and other vehicles.

So, I arrested him as he violated sec 279 IPC and 181/184 M.V Act. at 12.15 hrs. I also seized the vehicle with a view to prosecute him U/S 279 IPC and 181/184 M.V Act. in presence of witnesses. The whole process of seizure was completed in between 12.45 hrs to 12.55 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 181/184 M.V Act. may kindly be initiated against Imran Sk (22yrs) S/o Sk Ibrahim of Village- Baishyakuli, PS- Para, Dist- Purulia.
