In producing herewith one arrested accd. person namely Sahabub Osta @ Buluya (23 Yrs) S/o Mahabub Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia with seized article i.e 30 (Thirty) pces sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list. I beg to submit that today (14.07.2022) during my Day Mobile duty, I received credible source information from my reliable source that one person was carrying Country Spirit from Dubra side towards Santaldih accordingly I informed the matter before you and as per your direction myself along with force held raid at Koldih more and found that one person was coming riding on a motor cycle from Dubra side. Seeing police party he tried to flee away but he was apprehended after a short chase, with his red colour Hero (HF Delux) motor cycle having registration no -WB - 56S - 3375 and 30 (Thirty) pces sealed bottles of Country Spirit style as "DILKHUSH" each bottle contains 600 ml. On demand he failed to produce any valid license and paper for possessing the said quantity of country sprit. He also confessed that he collect the said quantity of country spirit from Dubra bazar for his illegal business of selling country spirit. It was reasonably believed that he was running his illegal business of country spirit at Udaypur and Nodiha G.P area and local people used to consume liquor from him for his illegal gain and loss.

So I seized 30 (Thirty) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which from his position. I prepared seizure list and label in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members.

The above noted arrested accd person namely Sahabub Osta @ Buluya S/o Mahabub Osta of Vill- Bamunbaid, PS- Para, Dist- Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.
