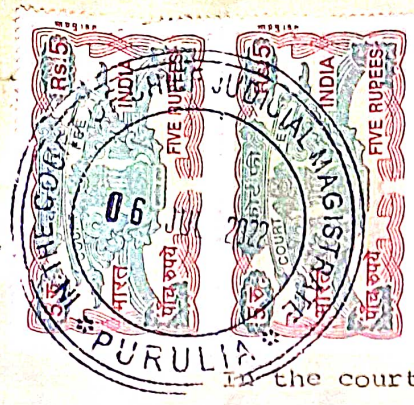

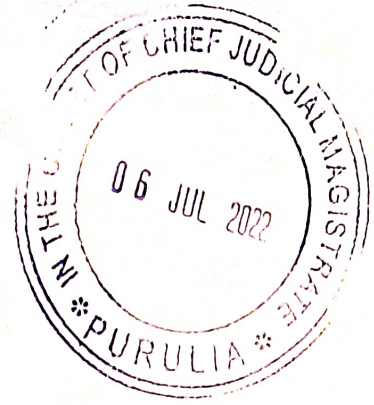

one accused i) Subhash Gope son of late Bhutu Gope, 2) Bharati Gope w/o Subhash Gope, iii) Biddut Gope son of Subhash Gope came to the complainant's land with deadly weapons and all gharoud the complainant, suddenly the accused Subhash Gope caught hold his hand and Biddut Gope assaulted him with iron rod on his head and caused bleeding injury over the head, hearing the ^{u.f.m.}commisson the complainant's and his son Ranjit Gope came to the spot and tried to save him but the aforesaid accused Biddut also assaulted his son with a iron rod.

That the informant protested against such illegal act of the accused^{u.f.m.}, hearing the ^{u.f.m.}commisson the para people came and ^{u.f.m.}save the informant and his son and they were taken to the hospital by village people, police did not take any action and adviced us to go to ld.court as well as the petitioner lodged complaint before the S.P. but did not take action.
