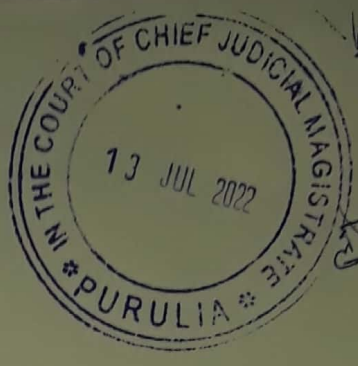

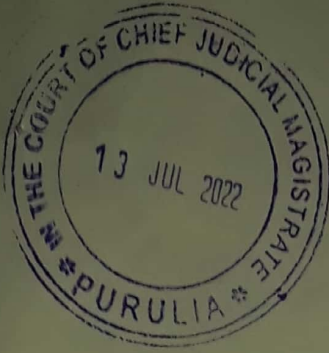

Most respectfully begs to submit as follows:-

1. That the complainant/petitioner is a resident of Puncha, P.O. & P.S.Puncha, Dist.Purulia and within the jurisdiction of your Honour's Court.
2. That on 17-05-2022 at about 8.00 P.M. the above-named accused persons were ~~ARMED~~ armed with deadly weapons like lathi, iron rod etc. and came to the house of complainant and surrounded the house of the complainant and shouted with filthy languages. That after hearing the commotion of the accuseds the complainant came out from his house. Suddenly the accused Nos. 1 and 2 assaulted the complainant by iron rod indiscriminately. That due to such attack ~~on~~ on the complainant, he became perplexed and sustained injury and he became injured with profused bleeding and became senseless. That seeing the such <sup>horrible</sup> condition of the complainant the accused persons left the complainant and fled away. But on the way they broke down the Hero Honda plus motor cycle of the complainant being Regn. No. WB-56B-0639 That it is pertinent to say that the complainant have got injury on his hand and backside of the body and also other parts of the body.
3. That on the date of incident I went Puncha P.S. ~~and~~ and informed the matter to O.C.Puncha P.S. But the police of Puncha P.S. did not take any action against the above-named accused persons. But at the same time the police of Puncha P.S. advised the complainant to take shelter before the Court of Law.
4. That thereafter I lodged complaint before the Superintendent of Police, Purulia on 20-05-2022. But the S.P.Purulia did not take any action against the said accuseds. Hence this delay.


5. That be it mentioned here that the petitioner is very poor. He has no capacity to continue the case at his own expenses. Moreso, there is some medical document which is required for investigation.
