Sub: FIR for illegal ploughing and uprooting the newly planted seedlings under govt. scheme at Asanboni under Manbazar-1 range.

Respected Sir,

With due respect, as per Bihar Gazette notification there is 48.1818 acre forest land present at asanboni mouza. At the request of the majority of the people of Asanboni, we started plantation over 10 Ha of place(mouza- Asanboni, J.L no- 59, plot no-1953). But when we started plantation of that place with the help of maximum people of Asanboni and also help of Asanboni JFMC members, on that moment Naranath Baskey , s/o- late Lakhu Baskey and his son Sandip Baskey, S/o- Naranath Baskey at vill- Asanboni interrupts of forestry work without any legal reason. When we asked the reason, he said that he has some land under Asanboni mouza. So we told him to submit his legal document, but he failed to submit such documents. He started to cultivate forcefully obstructing the forestry work and violating 32g of IFA,2(ii) of FCA 1980, 120B of IPC and provokes some people and threatens JFMC members.

Today morning, I received the news from the reliable source (Forest committee) that Naranath Baskey and his son Sandip Baskey uprooted approx. three hundred (300) no of Akashmoni seedlings which is planted on 28th july under scheme SPAP (State plan).As soon as the news was received I along with my staff went there and saw that the fact is true. he again violated 32g of IFA, 1927 ,120B, 183,186,189,190 of IPC and 2(ii) of FCA 1980, and Sec(3) of the PDPP Act, 1984 as these plantation are government property created out of govt. money.

In this circumstances, I hereby request you to look into the matter and take necessary steps regarding the above matter and lodge a FIR with your police station and oblige me thereby.

According to 12/12/1996 Godavarman case(T. N Godavarman Thirumulpad vs union of India & ors on 12 december,1996 Indian kanoon) Hon'ble court has concluded the followings:-

- (A) The forest conservation Act, 1980 was enacted with a view to check further deforestation which ultimately results in ecological imbalance; and therefore the provisions made therein for the conservation of forest and fore matters connected there with, must apply to all forest irrespective of the nature of ownership or classification thereof. The word "forest" must be understood according to its dictionary meaning. This description cover all statutorily recognized forests, whether designated as reserved, protected or otherwise for.

(B) The purpose of section 2(i) of forest conservation Act. The term "forest land" occurring in section 2 will not only include "forest" as understood in the dictionary sense, but also any area recorded as forest in the GOVT. record irrespective of ownership. This is how it has to be understood for the purpose of section 2 of the Act. The previous enacted in the forest conservation Act. 1990 for the conservation of forests and the matters connected therewith must apply clearly to all forests so understood irrespective of ownership or classification thereof.
