Sir,

In producing herewith the arrested accused persons namely (i) Raghubir Duari (22) S/O Chitta Ranjan Duari, (ii) Chitta Ranjan Duari (57) S/O Lt. Akul Ch. Duari, (iii) Smt Jhunu Duari (42) W/O Chitta Ranjan Duari all of Vill- Ramdih, PS-Purulia (M), Dist-Purulia. I do hereby submit that today (03.07.2022) as per source information and as per direction of LC Purulia (M) PS, myself along with force and LC/648 Mummun Bouri left Ramdih village vide Purulia (M) PS GDE No 138 Dt. 03.07.2022 and enquire the information of Child Marriage.

The fact of the information was one Namita Rakhit (15) D/O Sahadeb Rakshit of Vill-Paradih, PS-Purulia (M), Dist- Purulia compelled to marry with one Raghubir Duari (22) S/O Chitta Ranjan Duari of Vill-Poradih, PS-Puncha, Dist-Purulia.

On arrival at Ramdih village I found the girl was present at the house of the Raghubir Duari and the family members of the Raghubir Duari present there. On arrival of Police the body languages of the father and mother of the Raghubir Duari shattered. In course of primary enquiry it came to light that the minor girl was taken to the house of the Raghubir Duari at Ramdih village deceitfully and she was compelled to marry by creating mental trauma and physical threat.

As per statement of the minor girl that one Raghubir Duari and his parents forcefully arrange the marriage on 01.07.2022 evening. After marriage of the girl with Raghubir Duari taken her in the house of the Raghubir Duari by his family members and dumped there. Father of the boy Chitta Ranjan Duari was compelled to give shelter to them on the ground of affection. Chitta Ranjan Duari affectionately provided shelter to both of them. I recovered the minor girl by issuing recovery memo, took safe custody of the girl by issuing Safe custody memo and I arrested (i) Raghubir Duari (22) S/O Chitta Ranjan Duari, (ii) Chitta Ranjan Duari (57) S/O Lt. Akul Ch. Duari, (iii) Smt Jhunu Duari (42) W/O Chitta Ranjan Duari all of Vill-Ramdih, PS-Purulia (M), Dist-Purulia of solemnising child marriage deceitfully. I issued Memos of arrest to the attested persons and revealed the ground of arrest of them and their relatives. I am to note here that I found the vermilion at forehead of the girl. I am to further note here that there was huge flow of sentiment found in the locality which may turn into law & order issues. As such I don't have any other substitute apart from the arrest of the accused persons.

Myself left for PS along with recovered girl, safe custody the girl and arrested persons along with relevant papers and investigation kit box by PS Govt. vehicle. On arrival at PS I type this letter of complaint at our PS computer and submitted to LC Purulia (M) PS through duty officer for taking necessary action as per law. I handed over all the relevant papers, recovered girl, safe custody boy and the arrested accused persons to the duty officer
