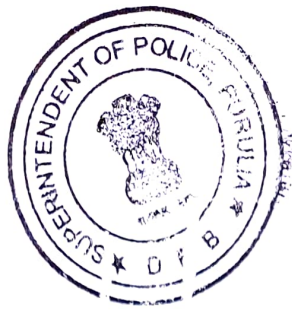

I, Amaresh Das, Sub-Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles viz (1) 01 (one) Pc. Domestic LPG Cylinder of HP Company with filling LPG, S.L No- IS3196PART (2) 01 (one) Pc. Domestic LPG Cylinder of INDANE Company (empty), S.L No- ISB19GPARI LPG (3) 01 (one) Pc. Domestic LPG Cylinder (empty) ,S.L No- IS3196PARI1 LPG (4) 01 (one) Pc. Old and used Oven made by Iron & fitted 01(one) Regulator valve and Rubber Pipe length about 3 feets, these articles were used for commercial business at Sweets shop to the effect that today on 14.07.2022 on the basis of secret and credible information I, along with ASI Prabir Mukherjee, W/C 88 Pradyut Mandal, HG- 1427 Beni Madhab Char all of DEB Purulia had been to Purulia (M) PS and submitted one requisition to I/C Purulia (M) PS for rendering assistance for workout the credible information under the jurisdiction of Purulia (M) PS at 11:05hrs. which has been noted in GD vide Purulia (M) PS GDE No. 635 dtd. 14.07.2022 at 11:15 hrs. Thereafter we along with officer and force of Purulia (M) PS (ASI Biswajit Kalindi with Force) left for Kalidasdih (Imundi) under Purulia (M) PS to work out the information. On arrival at Kalidasdih (Imundi) at about 12:05 hrs. to work out the information and holding raid & search in the sweets shop of one Parmeswar Mahato s/o Lt. Fatik Chandara Mahato of Vill. Kalidasdih (Imundi), P.S-Purulia (M), Dist Purulia Style as sweet shop which is located Kalidasdih (Imundi) more. During holding raid in the shop & also visited the business premises of sweet shop of Parmeswar Mahato and noticed 03 (Three) nos. of domestic LPG cylinder kept inside the sweets shop along with apparatus. The owner namely Parmeswar Mahato was using said Domestic LPG Cylinders for preparation of sweets and other commercial activities in his shop which are illegal. I asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also using domestic LPG Cylinders for running business of his sweets shop. But he failed to produce any valid documents / license before me for using such Domestic LPG Cylinders in his sweets shop. Thereafter I seized the above noted Domestic LPG Cylinders and other accessories which he was used for his commercial business after observing all formalities relating to search and seizure in between 12:15 hrs to 12:45 hrs. with proper labeling in presence of owner of the sweets & public witnesses under proper seizure list from the sweets shop of Parmeswar Mahato from his possession.



Hence the sweets shop owner Parmeswar Mahato violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985 & Regulation of supply and distribution order 2000, Subclause 1(c). Hence the owner of sweets shop has committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act'1955.


In course of local enquiry it revealed that the Owner Parmeswar Mahato is running clandestine business of commercial purpose by using LPG Domestic Gas Cylinder instead of commercial LPG since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to the Govt. and also out of greed to earn more profits for commercial purpose. Commercial use of Domestic Cylinders is a grave concern in our society and due to this the consumers of domestic cylinders faces various problems including this scarcity of domestic LPG cylinders.

The above noted seized articles as mentioned in S/L No. 01 to 03 were left in Zimma to one owner of M/S Raghampur INDANE Gramin Vitarak dealer namely Sujit Kumar Rajak S/O- Lt. Krishna Pada Rajak of Vill- Raghampur, P.S- Purulia (M), Dist.- Purulia vide his dealer code no. SAP261 in anticipation of kind approval of the Ld. CJM, Sadar Court, Purulia.

I therefore request you to start a case u/s 7(1)(a)(ii) of E.C.Act'1955 against accused Parmeswar Mahato s/o Lt. Fatik Chandara Mahato of Vill. Kalidasdih (Imundi), P.S-Purulia (M), Dist Purulia.

As per kind order of SP. DEB, Purulia ASI Swapan Chakraborty of DEB, Purulia will investigate the case.
