Sir,

I hereby lodge this Complaint against 1. Sanjoy Dubey, son of Late KalipadaDubey, 2. Ashok Kumar Dubey, son of Late UmapadaDubey 3. Sanjay Kumar Dubey, son of Sri Shibaprasad Dubey and 4. Bhim Dubey son of Late Mathur Dubey, all are residents of Village- Sibdih, P.S-Purulia(M), District- Purulia, on the following facts:

- 1. That the Property bearing R.S Plot no. 562 of Mouza- Sibdih originally belonged to and was owned and possessed by SanjoyDubey, Ganesh Dubey and Kartik Dubey, all sons of Late Kalipada Dubey of Sibdih.
- 2. That in the aforesaid Plot Sanjoy Dubey had 29 decimals of Land in his share. Said SanjoyDubey and his 2 brothers Ganesh and Kartik and one Susama Sukul by a registered Sale Deed being no. 2441 dated 22/04/2003 sold the aforesaid R.S Plot no. 562 after taking adequate consideration in favour of myself and my 2 brothers Pankaj Kumar Dubey and Shiba Prasad Dubey.
- 3. That in the aforesaid Plot no. 562 Sanjoy Dubey had 29 decimals of Land in his possession which he sold to us in its entirety. After purchase, we took possession of the same and amalgamated the property with our previously purchased R.S Plot no. 566 which was/is also our purchased Land. After purchase we the 3 brothers are in possession of both the plots.

4. That on 03/04/2022 when I was in the Fank along with my men at that time accused Ashok Kumar Dubey and Sanjay Kumar Dubey came near the Tank and disclosed that they will possess the same on being questioned the said persons disclosed for the first time that they have purchased R.S Plot no. 562 from accused Sanjoy Dubey.

5. That I had immediately obtained the certified copy of the Deed and on perusing the Deed (being No. 505 for the year 2022 of the Office of A.D.S.R, Purulia) I came to learn that Sanjoy Dubey, son of Late KalipadaDubey in collusion and concert with other 2 accused Ashok Kumar Dubey and Sanjay Kumar Dubey have manufactured a Deed and Sanjoy Dubey sold 20 decimals of Land out of R.S Plot no. 562 of Mouza-Sibdih in favour of Ashok Kumar Dubey and Sanjay Kumar Dubey. While Bhim Dubey son of Late Mathur Dubey was the attesting witness.

6. That said Ashok Kumar Dubey, Sanjay Kumar Dubey and Bhim Dubey had sufficient knowledge that Sanjoy Dubey had already sold his entire share in R.S Plot no. 562 in our favour and by suppressing the earlier Deed the said accused persons have manufactured the Deed.

7. That accused Sanjoy Dubey has deceived us and has cheated us by manufacturing the Deed in the aforesaid self same Land. Said Sanjoy Dubey had no interest in Plot no. 562. So the Deed dated 28/01/2022 is illegal and invalid and in spite of notice and knowledge they brought is a clear case of forgery. It was done to deceive us and Sanjoy Dubey in collusion with the accused Ashok, Sanjay and Bhim have prepared the forged Deed. We are still in possession of the Land since our purchase.

I therefore on behalf of my other 2 brothers request you to take punitive step against the aforesaid persons. The said persons are openly giving out that they will cause harm to us. The said Sanjoy Dubey and 3 others are Land Brokers and they are always trying to cheat the innocent people by manufacturing some Deeds.
