I, the undersigned, am the legally married wife of Sri Rahul Sharma, s/o Sri Shankarlal Sharma, resident of 172, Bangur Avenue, Block-B, 5th Floor, Flat-5B, Kolkata-700055, and our marriage was solemnized on 02/07/2021 in accordance to the Hindu Laws of Marriage and the rites and customs prevailing in our society at Sagar Raj Resort, Purulia.

At the time of marriage as per the demand of my husband and my in-laws family members, my parental family members had to pay cash of Rs. 15000/- and Rs.51,000/- in Cheque from the account of my brother-in-law Rohit Sharma, Gold Ornaments of 23.200 gm amounting to Rs.1,21,150/-, Silver Ornaments of 108.05 gm amounting to Rs.8020/-, Various Costly Accessories, Furniture, Electronics Articles, Beddings and other utensils to them as dowry.

After our marriage, I went to my in-law's house and also started residing with my husband along with my mother-in-law Smt. Saroj Sharma, w/o Shankar Lal Sharma as well as my sister-in-law Harsha Sharma, d/o Shankar Lal Sharma in a joint family and in a common mess situated at resident of 172, Bangur Avenue, Block-B, 5th Floor, Flat-5B, Kolkata-700055. But soon after our marriage, my husband, my mother-in-law and sister-in-law started to humiliate me and also started to use abusive languages. They started to torture me both physically and mentally on various ways as they are not satisfied with the dowry paid to them. I often used to be beaten by my husband. My mother-in-law and sister-in-law used provoke my husband. I used to maintain my entire in-law's family as a Hindu devoted wife and used to do all domestic works of the house just like a maid servant. My sister-in-law always used to interfere with the personal matter of myself and my husband. She often used to sleep in our room in between myself and my husband in night also. My husband never raised any objection for the

same. Whenever I protested, I used to face inhuman torture by my husband and his sister. On 12/10/2021, I was assaulted by them due to such kind of protest by me. I was also not permitted to even talk with my parental family members over phone. On 20/10/2021 I was brutally assaulted by my husband as I tried to contact with my mother by using my husband's phone.

My husband never took any care to myself. He neither performed his duties towards myself. Subsequently, my husband and my in-law's family members started creating persistent torture for demanding a further amount of 1 lakh as additional dowry from me and from my parents which we failed to pay. Lastly on 07/11/2021, I was driven out from my in-laws house and at that time my husband and his family members also snatched all my Stree Dhan Articles and all my Educational Certificates, Aadhar Card, Voter Card, Passport etc. and presently those are still lying with them. Thereafter with the intervention of my family members a joint sitting was held in the month of May, 2022 wherein my husband and his family members assured me to bring me back within a short period, but seeing lapse of considerable period of time when I contacted with my husband over telephone on 07.07.2022, he started to abuse me in filthy languages and threatened me of dire consequences if I further tried to contact with him.

Thus, my humble prayer before you to take proper and strong action against my husband and his family members as stated herein above in accordance to law.
