Sub: Prayer for starting a specific case against one Amar Gorai @ Raju (26 Yrs) S/O- Late Kalipada Gorai of Chakda, P.S- Tamna P.S, Dist- Purulia (Motor Cycle Rider having Regd. No-JH 09P 9607, TVS Apache RTR).

Respected Sir,

With due respect I PSI Ashoke Mahata, beg to submit before you that on 04/07/2022 at about 20:15 hrs while myself along with C/-1479 Anup Mahato, C/-2499 Rintu Mandal were performing Naka Checking duty vide Purulia (T) PS CC No-1671/22 Dated-04/07/2022 at Judges Banglow More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Joypur side **driving dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Judges Banglow More. On interrogation he made incoherent statement at different time. He disclosed his identity as Amar Gorai @ Raju (26 Yrs) S/O- Late Kalipada Gorai of Chakda, P.S- Tamna P.S, Dist- Purulia. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-181/184 MV Act. So I seized the Motor Cycle having Regd. No- JH 09P 9607, TVS Apache RTR, at 20:45 hrs to 20:55 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Amar Gorai @ Raju (26 Yrs) S/O- Late Kalipada Gorai of Chakda, P.S- Tamna P.S, Dist- Purulia at 21:05 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Amar Gorai was released on bail.

So I pray specific case may kindly be registered against the accused namely Amar Gorai @ Raju (26 Yrs) S/O- Late Kalipada Gorai of Chakda, P.S- Tamna P.S, Dist- Purulia (Motor Cycle Rider having Regd. No-JH 09P 9607, TVS Apache RTR) for committing offence U/S-279 IPC & R/W Section-181/184MV. Act.
