Sir,

In producing herewith one arrested accused person namely Sk. Minaj @ Sk. Bablu (39 yrs) s/o- Sk. Safik of Ward No- 08, J.K. College Road, PS- Purulia (T), Dist- Purulia under arrest memo alongwith seized articles under proper seizure list and being labeled properly.

- 1) 21 (Twenty One) bottles of Country Spirit styled as 'Dil Khush' contains 600 ml each strength 80° UP
- 2) Out of 21 (Twenty One) bottles 01(one) bottle is kept as sample.

I, PSI Ashoke Mahata, beg to report that while I was performing special raid mobile duty vide Purulia (T) PS GDE No- 1105 dated 18.07.2022, at about 19:25 hrs I received a secret telephonic information from source that one person namely Sk. Minaj @ Sk. Bablu (39 yrs) s/o- Sk. Safik of Ward No- 08, J.K. College Road, PS- Purulia (T), Dist- Purulia is selling country spirit illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers at Bus Stand waiting hall under Purulia(T) PS, Dist.- Purulia.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/586 Bholanath Dey and NVF/892 Rupsing Besra all of Purulia (T) PS proceeded to work out the information.

After sometime we reached near Bus Stand, keeping our Govt. vehicle at a reasonable distance we proceeded towards Bus Stand waiting hall as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation the said person disclosed his identity as noted above. On search of the house we found 21 (Twenty One) bottles of Country Spirit styled as 'Dil Khush' contains 600 ml each strength 80° UP. On further interrogation Sk. Minaj @ Sk. Bablu confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit. As such at about 19:55 hrs to 20:10 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after seal and label properly. I also took one bottle as sample and arrested him at 20:15 hrs after observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
