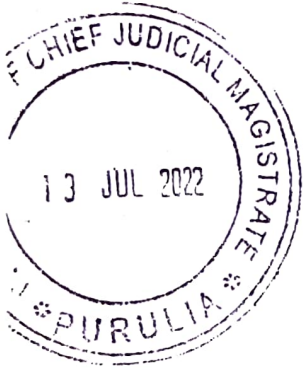

The Complainant above named begs to state as follows:-

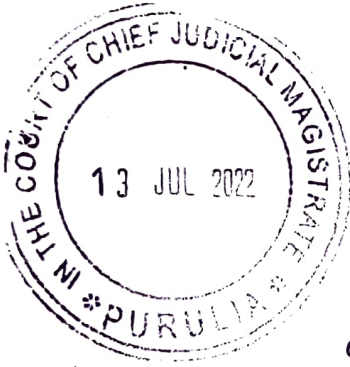
1. That the Complainant Chandan Kumar Jha son of Sri Pravakar Jha is a permanent resident of Loco Shed Para situated at Purulia Town within P.S. Purulia town and under the jurisdiction of this Court.
2. That the Complainant and his father has been running a book shop under name and style Pravakar Pustak Sadan situated at Barakar Road, Purulia.
3. That the Accused Person is a Book Supplier attached to Children Choice Publication Pvt. Ltd. situated at Plot no. 55/56, Delhi Road, Phase II, Industrial Area Mohkam Pur Meerut Uttar Pradesh.

4. That the Accused Person who used to supply Books to the father of the Complainant came to the said Book Shop on 17.06.2022 at about 11 AM along with his two men in absence of the father of the Complainant and demanded a hefty amount owing to supply of Books from the Complainant.
5. That the Complainant requested the Accused Person to wait for his father to come but hearing so he suddenly started abusing the Complainant in gutter and filthy languages and when the Complainant further requested him not to lose his temper he became enraged and more aggressive and the said Accused Person along with his two men caught hold of the Complainant and started beating the Complainant with fist and blows.
6. That when the situation became uncontrollable the staffs of the Complainant namely Apu Paul and Gaju Das intervened and they somehow managed to rescue the Complainant.
7. That thereafter the said Accused namely Arun Kumar Agarwal along with his men went outside the shop and broken down the counter of the Shop by throwing a piece of Brick and on leaving the said place he openly shouted that he will murder the Complainant and his father by engaging Supari Killers.
8. That due to the Physical assault by the Accused and his men the Complainant suffered injuries for which he got himself treated at Sadar Hospital Purulia. The Complainant has documents to that effect.
9. That after recovering to some extent the accused on 18.06.2022 had been to the Purulia Town P.S. to lodge Complaint but the O.C.

attached to the Thana refused to register F.I.R. and/or to give any G.D.E. Entry and took no steps against the accused persons.

10. That when the concerned P.S. did not take any step the Complainant lodged written Complaint before Superintendent of Police, Purulia on 7.7.2022.

11. That the Petition is made bonafide.
