

Most respectfully begs to state:-

- 1...That the complainant is a resident Ketika, Purulia Municipality Ward No-9, P.O. Purulia, P.5. Purulia (T), District- Purulia, West Bengal, and within the jurisdiction of this Ld. Court.
- 2...That the complainant and the accused no.1 are known to each other since last one year as such the accused person one day told the complainant that she has good relation and influence over the heavy weight political leaders and she would helped the complainant to get her son Ranjan Mitra to qualified in TET examination to get job of primary teacher under government of west Bengal, who is as per NCTE rule 2 Years Diploma holder in D.E.L.E.D (Diploma in Elementary Education) and also seated in 2017 TET examination which was held on 31/01/2021.



- 3...That on 18.04.2022 the accused no.1 along with accused no. 2 and 3 came to the house of the complainant and accused No.1 Kalyani Paramanik introduced the Accused No.2 & 3 with the complainant as heavy weight Political Leaders of ruling party. The accused No. 2 & 3 always busy in their mobile phone during the stay in the house of the complainant talking with various people about the job of primary teacher and qualify in TET examination which was held on 31/01/2021.
- 4...That the accused person asked the complainant to pay Rs. 7, 00,000/-(Rupees seven lacks) in total to them to get his son qualify in the 2017 TET examination which was held on 31/01/2021 to get primary teacher's job under the state of West Bengal and also asked to pay Rs. 3, 00,000/- (Rupees three lacks) as advance and rest amount will be payable after the qualify his son in TET examination. The accused persons also promised to the complainant if his son somehow not qualifies in the TET examination they will return back the entire Rs. 3, 00,000/- (Rupees three lacks) received as advance.
- 5...That as the complainant has good relation with accused no.1 Kalyani Paramanik, she also introduced the accused no.2 & 3 with the complainant as heavy weight ruling party leader and he has direct link with the heavy weight leaders of state, the complainant on good faith gave Rs. 3, 00,000/- (Rupees Three lacks only) on 18/04/2021 to the accused person on good faith for the sake of the career of his son.
- 6...That after few days of receiving the said amount of Rs. Three lacks (Rs.300, 000/-) the accused persons started to avoid the complainant and also did not reply if the complainant tried to call over the telephone finally the son of the complainant also did not qualify in the TET examination 2017 which was held 31.01. 2021.
- 7...That the accused No.1 Kalyani Paramanik who introduced the accused No.2 & 3 with the complainant also started to avoid to meet the complainant on lame excuses.
- 8...That all the accused persons by hatching criminal conspiracy cheated the Complainant for their wrongful gain of Rs. 3, 00,000/- (Rupees three lacks) by which also amounting to Criminal breach of trust.
- 9...That now since 30.05.2022 the accused persons started to threaten the complainant with dire consequence by saying that they will kill the complainant if he would lodge any complaint against the accused persons. That the accused persons are very dangerous in nature and the complainant has reasonable suspicion that accused person are part of big racket to cheat the simple citizen various way by giving them false promise and finally cheat them.
- 10...That the complainant visited several times to the Purulia (Town) P.S. to lodge complaint against the accused persons but each and every time duty officer in table refused to lodge written complaint against the accused persons and finally on 6/06/2022 the complainant sent his typed complaint to the I.C. Purulia (T) P.S. through registered post.

11...That as no action has been taken against the accused person the complainant informed the matter to the S.P. Purulia on 13/06/2021 but all in vain the accused persons are roaming freely and started to threaten the complainant each and every day.

12...That having no other alternatives your Complainant filed this Misc. Petition u/s 156(3) of Cr.P.C. before this Ld. Court.
