In producing here with arrested 03 (three) accused persons namely (1) Sahadeb Kegra (40) S/o Jagat @ Jagadish Keora of Vill.- Dubradih, PS - Adra, Dist.- Purulia, (2) Ajoy Bed (35) S/o Amitav Bachchan Bed of Vill.- Dumurakuri, PS - Adra, Dist.- Purulia and (3) Chandan Singh @ Chanda (20) S/o Lt. Ram Ch. Singh @ Lombu of Vill.- Katadih, PS - Arsha, Dist.- Purulia and seized articles (1) one iron made "SABAL", (2) One Iron hammer with wooden butt and (3) One Iron made "Bhojali" lodged complain against them and 03 (three) others to the effect that on 17.07.22 night at 22:25 Hrs received a credible source information that a gang of dacoits being armed with deadly weapons assembled in beside the Bundla Bridge and preparing themselves for committing dacoity at Raghunathpur Town area. This diarized by duty officer SI Swapan Majumdar and as per order of I/C Raghunathpur PS myself along with C/-847 Uttam Hazra, C/-682 Mahadeb Rajak C/-1267 Nabin Patray all of Raghunathpur PS vide CC No. 2114/21 dated 17.07.22 at Raghunathpur PS to work out the information. We reached near Bundla Bridge on Purulia -Barakar road (SH-5) at 22:45 Hrs leaving the Police vehicle some distance and proceeded for the anticipated place on foot. At 22:55 Hrs reached at anticipated place led on ambush being led by the source and in the moon light we noticed that 06 persons were assembled in the left side Bundla Bridge behind the bush and those persons are whispering from which it is clear that they are preparing themselves to commit dacoity at Raghunathpur PS area as it could be audible from the talks of the assembled criminals. We watched them and cordoned them. Then after disclosing our identity, I commended them to surrender but they did not pay any heed and tried to flee away. We succeeded in rounding up only 03 (Three) of them while the rest 03 persons were able to escaped despite hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the above noted articles from the exclusive possession of the above noted apprehended persons, after observing all formalities I seized the same under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there for committing house docoity but they could not say about the names of other co-accused persons. I am to note here that I have to conducted search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity which may be endanger of life of Public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing dacoity at Raghunathpur PS area. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Sahadeb Keora (40) S/o Jagat @ Jagadish Keora of Vill.- Dubradih, PS – Adra, Dist.- Purulia, (2) Ajoy Bed (35) S/o Amitav Bachchan Bed of Vill.- Dumurakuri, PS – Adra, Dist.- Purulia and (3) Chandan Singh @ Chanda (20) S/o Lt. Ram Ch. Singh @ Lombu of Vill.- Katadih, PS – Arsha, Dist.-Purulia along with 03 (three) unknown others under proper section of law and arrange its investigation.
