In producing herewith the arrested accused persons namely (1) Manoj Mishra @ Sanjoy Mishra (36) S/o Asok Mishra of Kushberia Sitalpur, PS - Beliapur, Dist.- Dhanbad (Jharkhand), (2) Arun Mishra (41) S/o Lt. Nandalal Mishra of Kushberia, Sitalpur (Birsinghpur), PS - Beliapur, Dist.- Dhanbad (Jharkhand), (3) Kishan Mishra @ Krishna (38) S/o Sunil Mishra of Kushberia Sitalpur, PS - Beliapur, Dist.- Dhanbad (Jharkhand), (4) Bhagbat Paul (27) S/o Anath Paul of Do, (5) Binod Mahato (41) S/o Lt. Rishikesh Mahato of Do, (6) Intaz Ansary (36) S/o Lt. Khalil Ansary @ Badhi of Jamua, PS - Raghunathpur, Dist.- Purulia and (7) Jabber Ansary (38) S/o Lt. Golam Ansary of Jamua, PS - Raghunathpur, Dist.- Purulia and seized (1) One Scooter without number plate loaded with approx 05 Qntls. Coal, (2) One Scooter bearing Reg. No. WB 38C/5660 loaded with approx 05 Qntls. And (3) One Scooter without number plate loaded with approx 05 Qntls. Fact of the case in brief is that on 22.07.2022 myself along with ASI Manoj Kr Das C/185 Rajesh Roy, C/194 Bijoy Das, NVF/189 Swapan Paramanik, all of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2157/22. At about 07:05 hrs. received a credible source information that the above noted scooters loaded with coal were coming from Kargali side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached at Kargali near Durga Mandir on Kargali - Cheliyama Road and waiting there. At about 07:30 hrs we noticed that 03 (three) scooters coming from Kargali Ghat side. We stopped the above noted said scooters loaded with coal. On asking rider of the said scooters along with others failed to produce any papers in respect of said loaded Coal as well as papers in respect of those scooters. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those scooters and other above noted involved accused persons collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with scooters are transporting the said coal illegally. As such I arrested of those persons after observing all formalities and narrating their ground of arrest. I also seized those 03 (three) scooters loaded with approx 05 (Five) Qnts. Coal in each containing in plastic bags scooter under proper seizure list duly signed by the accused persons and witnesses. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each scooters collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Manoj Mishra @ Sanjoy Mishra (36) S/o Asok Mishra of Kushberia Sitalpur, PS – Beliapur, Dist.- Dhanbad (Jharkhand), (2) Arun Mishra (41) S/o Lt. Nandalal Mishra of Kushberia, Sitalpur (Birsinghpur), PS – Beliapur, Dist.- Dhanbad (Jharkhand), (3) Kishan Mishra @ Krishna (38) S/o Sunil Mishra of Kushberia Sitalpur, PS – Beliapur, Dist.- Dhanbad (Jharkhand), (4) Bhagbat Paul (27) S/o Anath Paul of Do, (5) Binod Mahato (41) S/o Lt. Reshikesh Mahato of Do, (6) Intaz Ansary (36) S/o Lt. Khalil Ansary @ Badhi of Jamua, PS – Raghunathpur, Dist.- Purulia and (7) Jabber Ansary (38) S/o Lt. Golam Ansary of Do as per law and arrange for its investigation.
