Sir,

In producing herewith the arrested accused persons namely (1) Sk Aslam @ Aslauddin (23) S/o Sk Pappu of Vill.- Murulia, PS- Santuri, Dist.- Purulia, (2) Sk Jahid (32) S/o Sk Momrej of Do, (3) Sk Hamju (25) S/o Sk Soleman of Do, (4) Sk Sayeed @ Sahid (24) S/o Ajijul Sk of Do, (5) Sk Chhatu @ Irsad Alam (21) S/o Sk Aktar of Do and (6) Jiban Nag (38) S/o Lt. Dipak Nag of Vill.- Bhamuria, PS - Neturia, Dist.- Purulia and seized (1) One Scooter bearing Reg. No. BR 16M/1719 loaded with 05 (Five) Qntls. (Approx) coal in a plastic bag from Sk Aslam @ Aslauddin, (2) One Scooter without Number Plate loaded with approx 04 (Four) Qntls. coal in a plastic bag from Sk Jahid, (3) One Scooter without Number plate loaded with approx 04 (Four) Qntls. coal in a plastic bag from Sk Hamju, (4) One Scooter bearing Reg. No. WB 38G/8813 from Sk Sayeed @ Sahid, loaded with approx 04 (Four) Qntls. coal in a plastic bag, (5) One Scooter without Number plate loaded with approx 04 (Four) Qntls. coal in a plastic bag from Sk Chattu @ Irsad Alam, (6) One Scooter without Number plate loaded with approx 04 (Four) Qntls. coal in a plastic bag from Jiban Nag. Fact of the case in brief is that on 24.07.2022 myself along with C/480 Uttam Bauri, C/386 Sibendu Sinha and NVF/1086 Sanatan Mahato, all of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2177/22. At about 05:05 hrs. received a credible source information that the above noted scooters loaded with coal were assembled and trying to stock at the vested land near at Jharukhamar Muri Meal under Raghunathpur PS. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached at Jharukhamar Muri meal on Purulia -Barakar Road and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that some persons having loaded coal with Scooters were assembled there, at that time we were able to apprehend 06 (Six) Nos. of Scooters with loaded coal and there riders. Others 12/14 unknown persons were fled away with their coal loaded Scooters. On asking the riders of the said scooters failed to produce any papers in respect of said loaded Coal as well as papers in respect of those scooters. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those scooters and others 12/14 unknown persons collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with scooters are transporting the said coal illegally. As such I arrested of those persons after observing all formalities and narrating their ground of arrest. I also seized those scooters loaded with Coal under proper seizure list duly signed by the accused persons and witnesses. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each scooters collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Sk Aslam @ Aslauddin (23) S/o Sk Pappu of Vill.- Murulia, PS- Santuri, Dist.-Purulia, (2) Sk Jahid (32) S/o Sk Momrej of Do, (3) Sk Hamju (25) S/o Sk Soleman of Do, (4) Sk Sayeed @ Sahid (24) S/o Ajijul Sk of Do, (5) Sk Chhatu @ Irsad Alam (21) S/o Sk Aktar of Do and (6) Jiban Nag (38) S/o Lt. Dipak Nag of Vill.- Bhamuria, PS – Neturia, Dist.- Purulia as per law and arrange for its investigation.
