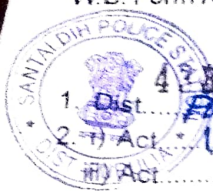

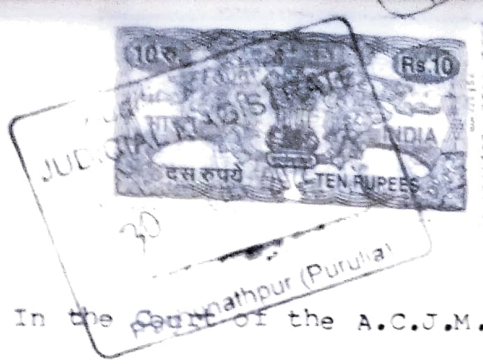

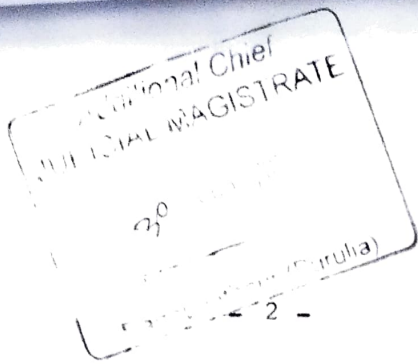

at Kanki Bazar.

The accused persons was with Tangi, Ballam Talowar,
with their hands and playing and dancing very dangerously
in front of the house of the complainant as such complainant
and protested them not to Play/dancing
if not otherwise any body might be sustain injury by
their weapons, hearing this all the above named accused
persons alongwith their weapons all on sudden entered into
the house of the complainant with-out giving any chance to
the complainant all the accused persons started to assaulted
the complainant by stick on his head, Samim Ansary assaulted
on his hand by sticks Kuddus Ansary assaulted the complainant
by stick on his Chest, Tajimuddin Ansary assaulted to Mafiz
Ansary by Waller on his difference person Parvej Ansary
assaulted to Mafiz Ansary by Tangi, due to this assault the
complainant and other sustain injuries blood stain Come out
from their body complainant shouted, by hearing shout local
people come there before leaving the house the accused
persons ransacked the house and house hold articles of the
complainant.

That the complainant and other injured persons were hospitali-
zed at P.S. Hospital Santaldih, and there after Dr.
referred Mafiz Ansari to Purulia Govt. Hospital for C.T. scan
and water treatment and he was admitted for few days, there-
after he was discharged from Hospital.

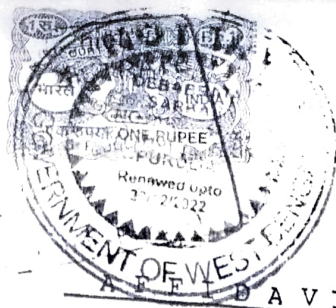
5. That the complainant after discharge from his hospital went to I/C Santaldih, lodge written complain against the accuseds
