Sub : Prayer for lodging FIR against accused Ajit Kumar Mahatha (45 yrs) S/O - Lt. Bishnu Charan Mahatha of Narkera, PO- Rangamatiya, PS-Chandankiyary, Dist- Bokaro (**Jharkhand**) U/S 46 A (c) Bengal Excise Act, 1909.

Sir,

In producing herewith one arrested accused person named as Ajit Kumar Mahatha (45 yrs) S/O - Lt. Bishnu Charan Mahatha of Narkera, PO- Rangamatiya, PS-Chandankiyary, Dist- Bokaro (**Jharkhand**) along with seizure - list and seized items as described below, I beg to state that on 14.07.2022 at about 16:25 hrs during special mobile duty I received a source information to the effect that one person is carrying illegally country spirit (বাস্পার) & (Dilkhush) at Gowai Bridge side area under this PS by a motorcycle having reg. no JH-09L/5645 with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Gowai Bridge to work out the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. At 16:45 hrs I reached near Gowai Bridge and detained the alleged person with the motorcycle and found that a blue color plastic bag (styled as Dalmia cement) is loaded in the motorcycle. On asked about his identity, he disclosed his name and identity as noted above and as well as admitted that he gathered the above noted country spirit for selling. However, I along with force started to search the plastic bag loaded in the motorcycle and found the following item in the bag -

1) 08 (Eight) bottles 70UP country spirit (বাস্পার) each bottle containing 300 ML.

01 (one) bottle of 300 ML taken (বাস্পার) out of the above as sample packet, labeled and sealed with sealing wax.

2) 12 (Twelve) bottles country spirit (Dilkhush) each bottle containing 600 ML.

01 (one) bottle of 600 ML taken (Dilkhush) out of the above as sample packet, labeled and sealed with sealing wax

I interrogated him about the purpose of the stocking and possessing such country spirit. He replied it was the business of him. However he could not show any documents/papers in support of the possession.

As such, I seized the above items along with the motorcycle having Reg.No -JH-09L/5645 (Hero CD Deluxe, black color), Engine No. HA11EA99H31222 and Chassis No. MBLHA11EH99H17568, as ALAMAT under proper Seizure List between 17:05 hrs to 17:25 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing of the country spirit illegally without any valid papers a prima-facie been made out and for the interest of proper investigation. Hence, I arrested the above accused at 17:35 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Ajit Kumar Mahatha (45 yrs) S/O - Lt. Bishnu Charan Mahatha of Narkera, PO- Rangamatiya, PS-Chandankiyary, Dist- Bokaro (**Jharkhand**).
