Sir,

In producing here with seized approx four (04) M.T. stone, and 03 Gaiti, 03 Sabal and 02 Belcha. I, SI Santosh Kr. Roy would like to inform you that today at about 16:45 hrs. in course of mobile duty I received credible source information that one Parimal Mandal, S/O - Samaresh Mandal of Vill-Teghoria, PS-Mejia, Dist-Bankura and Haren Mandal S/O- Late Mator Mandal of Vill. Ghoramurga, PS- Santuri Dist-Purulia and others are digging stone from illegal mines at near Chhairabari Village under Ambari Mouza, PS Santuri, Dist- Purulia. After receiving this information I informed to O/C santuri PS, As per Direction of O/C Santuri PS myself along with force proceeding towards illegal mines under Chhairabari village to work out the said information. When we reached near illegal mines under Chhairabari village, found that some persons were digging stone. Seeing the Police party they fled away from there leaving with their digging stone and some digging instrument i.e, 03 Gaiti, 03 Sabal and 02 Belcha. We tried to chase them but in vain. Accordingly I seized approx four (04) M.T stone, 03 Gaiti, 03 Sabal and 02 Belcha under proper seizure list in presence of available witnesses duly signed by them but during seizure there was no any local people. Thereafter arranging Tractor I brought the above noted seized articles to Santuri P.S. As such there is every reason to believe that the above noted persons are involved in illegal stone mining by fraudulent means in clandestine manner.

Therefore, I pray before you that a specific case against the above noted persons may kindly be started as per proper section of law.
