Sub: lodging FIR

Sir,

I, ASI Chittaranjan Mukhopadhyay of Tamna PS do hereby lodged this complaint that today (01.07.22) at about 19:55 hrs while I was performing mobile duty, received information from SI Tapas Kr. Mishra, OC, Tamna P.S. that a road accident took place near Damda village on Purulia – Tata road (N.H.- 32). Accordingly, I accompanied by scanty force arrived at Damda village on Purulia – Tata road (N.H.- 32) at about 20:05 hrs. There I found 50-60 people standing on the road surrounding two persons lying on road in critical condition. It was learnt that the cause of Incident was road accident. In no time, I took initiative to shift the two injured to hospital. But the persons obstructed me in removing the injured to hospital citing various local issues. They assaulted me and C/138 Bani Bandopadhyay, C/1509 Animesh Mukherjee and public driver Ashoke Mahato with lathi, fist & blows and pushed on ground causing injury to me and my staff. They threatened the police personnel. The accused persons damaged the police vehicle (hired) bearing Registration No. JH09Q-0183. The accused persons blocked the Purulia – Tata road (NH-32) for about one hour causing traffic jam and trouble to common people. I and my accompanied force treated at Chakaltore B.P.H.C, Purulia.

Hence, I pray that a case under proper section of law may kindly be initiated for taking further legal action against the 50-60 unknown accused persons.
