Respected Sir,

In producing herewith the arrested accused person namely Pakrasi Sing Sardar (24 Yrs.), S/o- Chutu Sing Sardar of Vill- Barakdih, PS- Tamna, Dist- Purulia along with seized article i.e. one Red colour Mahindra B 275 DI tractor having Reg. No- WB55A/7898, Engine No- RJL2EAN0530, Chassis No -MBNABAEXPJRL 04122 attached with Trolley without number plate loaded with sand approx. 100 cft.

The fact of the case in brief is that on 12.07.2022 at about 15:15 hrs received credible source information that one Red Colour Tractor is lifting sand illegally from Kansai Riverbed at Barakdih Sand Ghat under Tamna PS, Dist- Purulia and going towards Purulia - Tata road (NH-32). Accordingly, myself along with force i) C/391 Satya Sundar Kundu and ii) C/293 Subhasis Chakraborty left to work out the said source information. Then, we intercepted the aforesaid tractor near Fatepur village under Tamna PS, Dist- Purulia at about 15:35 hrs and found that the above noted tractor was attached with trolley without number plate loaded with sand approx 100 cft. But seeing the Police party, driver of the tractor fled away leaving the said tractor with sand loaded trolley beside Fatepur village on hot chased I apprehended the driver of the Tractor with the help of my force at Fatepur village under Tamna PS, Dist-Purulia. I asked the Driver of the said Tractor to produce for valid documents lifting the sand which is loaded on the above noted trolley of the said Tractor. But he failed to produce any valid document in respect of the loaded sand into the trolley of Tractor. So, I arrested driver of the Tractor namely Pakrasi Sing Sardar (24 Yrs.), S/o- Chutu Sing Sardar of Vill- Barakdih, PS- Tamna, Dist- Purulia after observing all legal formalities regarding arrest and also issued one copy memo of arrest to him and told ground of arrest and also informed his family members regarding the ground of arrest. On prolong interrogation, he confessed his guilt. Later on, I seized the above noted Tractor attached with trolley loaded with sand approx. 100 cft. In presence of witnesses through seizure list. So, there is every ground to reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the seized tractor having Reg. No- WB55A/7898, Engine No-RJL2EAN0530, Chassis No -MBNABAEXPJRL 04122 attached with Trolley loaded with sand approx. 100 cft.
