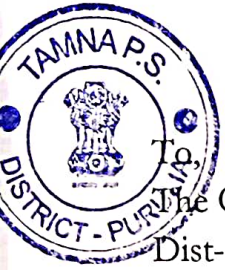
13. Action taken: Since the above report reveals commission of offence(s) of 46 A(C) of Bengal Excise Act-1909

Respected Sir,

I, SI Hemanta Kr. Sahababu of Tamna PS, Dist- Purulia producing herewith one arrested accused person namely Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia with seized articles i.e. 1) one white colour jarican containing Approx 08 Ltrs. ID Liquor 2) 05 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (18-07-2022) during PS mobile duty acting of a secret source information myself along with (1) HG/1815 Karamchand Kumar, (2) HG/1861 Dipak Kumar both of Tamna PS conducted raid in the house of accused person Shibaram Mahato at about 16:45 hrs and found that he was keeping and selling of ID liquor at his residence to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing Approx 08 Ltrs. ID Liquor 2) 05 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia as per proper section of law.
