
I, SI Goutam Kr. Bangal of Tamna PS beg to report that today myself along with C/1139 Jiban Senapati and HG/1815 Karamchand Kumar all are of Tamna PS were performing anti-crime evening mobile duty on Purulia - Manbazar road at Chakaltore more area under Tamna PS vide Tamna PS CC No- 3746/22 Dtd- 23.07.2022 & Tamna PS GDE No-1020 Dtd- 23.07.2022 at about 17:55 hrs, I found one blue black colour motor cycle without number plate bearing Chassis No- MBLJAW180L9L00632 & Engine No- JA07ABL9L04637 coming from Manbazar side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted accused person after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the motor cycle and one original purchased challan vide No- 387 of the said seized Motor Cycle in presence of witnesses and informed him and his family member regarding the ground of arrest.


