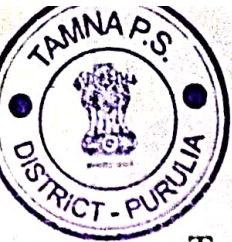

Respected Sir,

In producing herewith one arrested accused person namely Bimal Hembram (20 yrs) S/O- Bhaktu Hembram of Vill- Kultanr, P.O- Sirkabaid, P.S- Arsha, Dist- Purulia with seizure list and seized articles, I beg to submit that today i.e on 25.07.2022 at about 13:35 hrs during day mobile duty at Tamna PS area, received a secret source information that one unknown person ride with one bike loaded with I.D Liquor came towards Rampur village and as per order of O/C Tamna PS, I ASI Sudhir Tudu of Tamna PS along with force proceed to Rampur village under Tamna PS and when we reached at near Rampur village at about 14:15 hrs found that one person tried to fled away after seeing Police party leaving his Motor Cycle. On hot chased I apprehended the said Motor cyclist with the help of my force at near Rampur village under Tamna PS, Dist- Purulia. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for carring I.D Liquor to selling. On demand he failed to produce any valid documents in respect of said I.D. Liquor. As such I seized (i) Eighteen (18) ltr. I.D Liquor containing a one white colour plastic jericane, (ii) One (01) ltr. I.D Liquor in a bottle taken out from eighteen ltr. I.D. Liquor as sample. & (iii) One black colour Hero Splender Pro Motor Cycle bearing Registration No-WB56K/1335 under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed his relative regarding the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Bimal Hembram (20 yrs) S/O- Bhaktu Hembram of Vill- Kultanr, P.O- Sirkabaid, P.S- Arsha, Dist.- Purulia committed offence u/s- 46 A(C) B.E. Act- 1909 for carring to sales of ID Liquor from Rampur village.

Under the fact and circumstances kindly take necessary lawful action against Bimal Hembram (20 yrs) S/O- Bhaktu Hembram of Vill- Kultanr, P.O- Sirkabaid, P.S- Arsha, Dist.- Purulia.
