On hot chased I apprehended the said Motor cyclist with the help of my force at near Rampur village under Tamna PS, Dist-Purulia. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for carring I.D Liquor to selling. On demand he failed to produce any valid documents in respect of said I.D. Liquor. As such I seized (i) Eighteen (18) ltr. I.D Liquor containing a one white colour plastic jericane, (ii) One (01) ltr. I.D Liquor in a bottle taken out from eighteen ltr. I.D. Liquor as sample. & (iii) One black colour Hero Splender Pro Motor Cycle bearing Registration No-WB56K/1335 under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed his relative regarding the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.
