
I, ASI Jagannath Rakshit of Tamna PS beg to report that today myself along with NVF/571 Bhakta Ranjan Pramanik and HG/1747 Ajit Hembram all are of Tamna PS were performing anti-crime evening mobile duty on Purulia - Manbazar road at Purulia - Manbazar road side area under Tamna PS vide Tamna PS CC No- 3765/22 Dtd- 25.07.2022 & Tamna PS GDE No-1103 Dtd- 25.07.2022 at about 18:05 hrs. at Durku more I found one black red colour Hero Honda motor cycle bearing Registration No- JH05AL/1019 was coming from Purulia side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him at Chandradih Nagar more under Tamna PS Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the black red colour Hero Honda motor cycle bearing Registration No- JH05AL/1019 in presence of witnesses and informed him and his family member regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Ananta Lal Mishra (45 Yrs) S/O- Lt. Jamini Kanta Mishra of Vill- Gopalpur, P.O- Bangurda, PS- Kamalpur, Dist- East Singbhum, Jharkhand.
