In producing herewith arrested accused person namely Amit Bouri (24 yrs) S/O Ashok Bouri of Vill-Chinpina, P.S- Raghunathpur, Dist- Purulia along with seized articles (1) One black colour Discover Motor Cycle bearing Reg. no- WB-56G/6266.

I beg to report that today myself along with C/571 Md. Hashib Khan, HG/1898 Anil Hembrom were engage in Day Mobile duty performing NAKA duty at Adra-Kashipur Pitch road near Wireless More under Adra PS, vide Adra PS C.C No-2598/22 dtd.18/08/2022 and Adra PS GDE No-726 at about 12:55' hrs, I found one black colour Discover Motor Cycle bearing Reg. no- WB-56G/6266 coming from Kashipur side towards Adra side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.
