- 16. That my husband and my in-laws are very dangerous and desperate in nature and I always stayed in fear at the instance of my husband and in my in-laws.
- 17. That I am a destitute and helpless law and seeking relief from your end to take legal action and stapes against my husband, father-in-law and mother-in-law.
- I, therefore request you to your good-self to take all possible legal and necessary steps against the Accused persons above named for their illegal activities so that I can get justice and to look into the matter very deeply and make arrangements so that the Accused Persons can be restrained behind the bar and a helpless woman can get Justice.
