In pending through one arrested person namely BK Hasin (26 yrs) S/O BK Inai of Vill- Sikaripara, PS - Kashiipur, Dist- Purulia along with seized One Red colour Mahindra B 27501. Tractor bearing Reg. No-WB81/2421 along with sand loaded Trilley without number plate seized under proper seizure list and memo of arrest in respect of the supra person before me.

The risk of the fact in a nutshell is that today 28.08.2022 when I along with force namely 1) C/1119 Susanta Kr Sinha 2) HG 3) Bala Singh Barter left the PS for performing Evening Patrol duty vide CC No-2459/22 Dated 28.08.2022 and Adm PS GDE No 1150 Dated 28.08.2022 in PS area. During my patrol duty, I received a tip off at 20:15 hrs that a suspicious tractor loaded with sand, sand was coming from Kantarungui village area GVC near road side towards Belko village. Subsequently, I along with force proceeded towards Belko to check out the tip off. While I along with force arrived at Belko I asked local people who gathered at that place to become witnesses but none came forward and all of them left the place. After that I found that one tractor was coming from Kantarungui village road side under Adm PS. I along with force intercepted the vehicle (Tractor) bearing Reg. No-WB81/2421 attached with Trilley without number plate loaded with sand after placing the guardrail on the road at 20:25 hrs at Belko village. More over found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name stated in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The innumeral statement of the driver purported to be a suspicious one to me. It was ascertained that the driver of the said tractor loaded the said sand in sakota with the owner of the vehicle by illegal means for selling the sand to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to believe that he is in collusion with the owner of the vehicle procured the said sand from Darkhewer River at Jankari Bahi Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver clearly confessed that he dishonestly deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part - VIII)/1176/M/90/M/17 Dtd 26.06.2020, regarding ban of sand lifting from Riverbed. So I seized the tractor bearing Reg. No-WB81/2421 along with sand loaded Trilley without number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely BK Hasin (26 yrs) S/O BK Inai of Vill- Sikaripara, PS - Kashiipur, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. The Search, seizure and arrest completed in between 20:45 hrs to 21:25 hrs. Thereafter, I brought the said tractor in Adm P.S.

Under the above facts and circumstances kindly take legal action against the driver namely, BK Hasin (26 yrs) S/O BK Inai of Vill- Sikaripara, PS - Kashiipur, Dist- Purulia and the owner of the vehicle and also owner of the said sand as they committed offence U/S 188/379/411/414/120B IPC & 21(1) [a] Mines and Minerals (R&D) Act-1957
