In performing my official duty I arrested person namely SK Hasan (26 yrs) S/O SK Inu of Vill. Sikarpur, PS - Kashipur, Dist. Purulia along with seized One Red colour Mahindra H 375D1, Tractor bearing Reg. No. WB81/2421, sowing with sand loaded Tralley without number plate seized under proper seizure law and issued of arrest in respect of the supra person before me.

The rest of the fact is a nutshell is that today 28.08.2022 while I along with help namely 1) C/1119 Bhawana Kr.Sinha Ji, P.D. 31, Bala Bieghi Baror left the PS for performing my official duty vide CC No.2459/22 Dated 28.08.2022 and Adra P.R. G.O.M. No. 1152 Dated 28.08.2022 in PS area. During my patrol duty, I received a tip off at 20:15 hrs that a suspicious tractor loaded with sand was running from Kasturanganj village near GVC more road side towards Beloi village. Subsequently, I along with force possessed towards Beloi to track out the tip off. While I along with force arrived at Beloi I saw local people who gathered at that place to become witnesses but none came forward and all of them left the place. After that I found that said tractor was coming from Kasturanganj village road side under Adra P.S. I along with force intercepted the vehicle (Tractor) bearing Reg. No. WB81/2421 attached with Tralley without number plate loaded with sand after placing the guard rail on the road at 20:25 hrs at Beloi village More and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incrimental statement of the driver purported to be a suspicious not to us. It was ascertained that the driver of the said tractor loaded the said sand in salient with the owner of the vehicle by illegal means for selling the same to make profit by dishonesty and they had been running a clandestine business. So it is reasonable to belief that he in collusion with the owner of the vehicle procured the said sand from Darkeswar River at Jankuri Bati Ghat by fraudulent means or theft by any means for transporting the same to run clandestine business. During interrogation the driver clearly confessed that he honestly deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part - VIII)/1.176/M/30/M/17 Dated 26.06.2020, regarding ban of sand lifting from Riverbed. So I seized the tractor bearing Reg. No. WB81/2421 along with sand loaded Tralley without number plate under proper seizure law in presence of available witnesses duly signed by them and also arrested the driver namely SK Hasan (26 yrs) S/O SK Inu of Vill. Sikarpur, PS - Kashipur, Dist. Purulia after informing the ground of arrest and issued Memo of Arrest against him. The Search, seizure and arrest completed in between 20:45 hrs to 21:25 hrs. Thereafter, I brought the said tractor to Adra P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely, SK Hasan (26 yrs) S/O SK Inu of Vill. Sikarpur, PS - Kashipur, Dist. Purulia and the owner of the vehicle and also owner of the said sand as they committed offence U/S 188/379/411/414/120B IPC & 21(1) (4) Mines and Minerals (Bhd) Act-1957.
