Sir,

I SI Uttam Kr. Mandal of Arsha PS in producing herewith one apprehended CCL boy Mainuddin Raja Khan (16 yrs) S/O Abdul Rahim both of Vill- Pithati, PS- Arsha, Dist- Purulia along with one original seizure list (recovered 01 firm Arms having length of 22 cm from the end point of butt to barrel, length of butt is 08.5 cm approx, barrel 08 cm approx, having trigger etc.

I, do hereby stated that on 04.08.2022 at 20.35 hrs, had been to village Pithati, PS- Arsha, Dist- Purulia for holding raid in the house of FIR named Mainuddin Raja Khan S/O Abdul Rahim of Vill- Pithati, PS- Arsha, Dist- Purulia in c/w Arsha PS Case No- 110/22 Dated- 04.08.2022 U/S- 341/323/325/307/34 IPC & R/W Section 25/27 Arms Act. Before held raid, I called the guardian as witness of our raid and search namely 1. Abdul Rahim S/O Md. Kuddus Khan & 2. Zahir Khan S/O Md. Sabbir Alam both of Vill- Pithati, PS- Arsha, Dist- Purulia.

During raid I apprehended-01 FIR named Mainuddin Raja Khan S/O Abdul Rahim of Vill- Pithati, PS- Arsha, Dist- Purulia. After apprehension he disclosed his identity himself as Mainuddin Raja Khan (16 yrs) S/O Abdul Rahim of Vill- Pithati, PS- Arsha, Dist- Purulia. After apprehension during search, I recovered 01 fire Arms having length of 22 cm from the end point of butt to barrel, length of butt is 08.5 cm approx, barrel 08 cm approx, having trigger etc, from his back side of waist, inside the back portion of his pant. On demand he could not produced any valid documents /license in respect of keeping such arms. So I seized the said arms under proper seizure list and sealed and labelled in presence of local witnesses and duly sign by the witnesses in between 21.05 hrs to. 21.35 hrs. I also took the signature of Mainuddin Raja Khan on the seizure list and a copy of seizure list handed over to him.

I like to note here that the apprehended CCL boy Mainuddin Raja Khan (16 yrs) S/O Abdul Rahim of Vill- Pithati, PS- Arsha, Dist- Purulia is a FIR named accused of Arsha PS Case No- 110/22 Dated- 04.08.2022 U/S- 341/323/325/307/34 IPC & R/W Section 25/27 Arms Act and prepared a apprehension memo accordingly.

Hence I submitted a complainant against accused CCL boy Mainuddin Raja Khan (16 yrs) S/O Abdul Rahim of Vill- Pithati, PS- Arsha, Dist- Purulia to start a specific case U/S 25 Arms Act.
