




That I am the/permanent resident of Village Mapuidih, P.O.-Anara, P.S.Para District Purulia which is my matrimonial house and my husband name is Sri Bijoy Bauri and at present residing at Village +P.O.Kantadih, P.S.Arsha, District Purulia under the C/o of my father Jagabandhu Bauri which is my father's house.


- 2..That The complainant is the legally married wife of Bijoy Kumar Bauri S/o Manţu Bauri and our marriage is/was solemn%ised on 19.11.2019 as per im Hindu rites and customs prevailing in our society and marriage took place at Village Kantadih, Basti within P.S.Arsha, District Purulia.
- 3..That after marriage I had been go to my matrimonial house at Village Mapuiuin, within P.S.Para , District Purulia and residing there as husband and wife .
- 4..That at the time of marriage my father Jagabandhu Digar as per demand of the complainant/shusband and rather in-law had paid Rs.52,000.00/- (Rupees Fifty too thousand)Cash, ornaments, utembils, Furnitures as per demand of the complainant's said husband and father.

5. That since marriage without any reason the complainant husband Bijoy Bauri, father-in-law Mantu Pauri, mother -in-law Kalpana Bauri, Sister in; haw Purnima Bauri mentally and physically tortured upon the complainant and deman@ded further dowary and they were not satisfaction the furnitures, utensils and

cash of Rs.52,000/- (Rupees fifty two thousand) but the husband and other family members are/were not satisfied and always used filthy languages to the complainant and says that the utensils and furnitures and ornaments are very lower category.

including cooking, serving the cooks meal to all the family not members inspite of that they were supply the sufficient fooding. clothing and medicines and necessary commodities of the petitioner complainant and her minor child and when the complainant demand those things then complainant was assaulted by fists and blows .The complainant husband and other family members demanded further dowery from the complainant's poor father but when the Complainant and her poor father have not fulfiled their demand they have tortured physically and mentally upon the complainant and her minor child, inspite off that all the tortured i.e. physically and mentally will bear by the complainant that good sense will prevail the husband and other ramily members.

7...That on 22.5.2022. at morning the husband Bijoy Bauri, mother-in-law Kalpana Bouri and sister -in-law Purnima Bauri tried to murder the complainant through kerosin oil upon the body of the complainant and the complainant to save the life and how managed and her minor child and shouting for help with loudly voice and the neighbours arecame to the spot and sove the Bife of the complainant and her minor son

in-law and sister in law by good assignlying by fists and blows driven out the complainant from the matrimonial house forcily snatching the minor boy who's age is 1 & 1/2 year old and thereafter the complainant was moving here & there and thereafter informed the matter to the complainant parents and they were came to the complainant matrimonial house and where they have no informaed about the complainant and her minor son and complainant not aware that her parents have come thereafter they were informed by the neighbour of the matrimonial house of the complainant and thereafter they were searched that they were noticed the complainant moving here and there and thereafter the complainat and Fari her parents went to the Anara PXS. and lodge writtencompliainant against and the complainant husband and other family members snatched

the minor children from the lape of the complainant and thereafter the Police of Anara Fari return back the minor child to the complainant and thereafter the complainant and her minor whild return back to the house of parents of the complainant thereafter the complainant & her minor child residing there, with the mercy of her parents & others.

3.. That the complainant thereafter informed this matter to the superintendent of police as well as Arsha P.S. but got no relief from the said concern so the complainant is liable to take shelter before this Ld. Court of law for justice.

It is respectfully prayed that your Honour would be pleased to accept the petition uss 156(3)Cr.P.C and directed to Arsha P.S.to treat it as a F.I.R.& be pleased to pass necessary order.
