Sir,

In producing here with one arrested accused person Nanigopal Majhi (43 yrs) S/O Lt. Mantu Majhi of vill Sirkabad, P.S.-Arsha Dist-Purulia along with following seized articles:

- 1) One white colour plastic container containing approx 16 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Janardan Kumar of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 23.08.22 at about 20.05 hrs. during my Spl. mobile duty at Arsha PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Sirkabad village. On receiving the source information I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 1243 Abodh Ch. Mahato and C/- 109 Surjatapa Dolai both of Arsha PS rushed to the house of above noted suspected person to work out the information vide Arsha PS C.C. No. 1718/22 dtd. 23.08.22. Reaching at Sirkabad village at about 20.35 hrs we fixed-up in the house of Nanigopal Majhi S/O Lt. Mantu Majhi of vill Sirkabad, P.S.-Arsha Dist-Purulia and found that selling of I.D Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized one white colour plastic container containing approx 16 ltrs. of ID liquor under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Nanigopal Majhi (43 yrs) S/O Lt. Mantu Majhi of vill Sirkabad, P.S.-Arsha Dist-Purulia under proper section of law.
