herewith, 01(one) New Holland. Plus tractor having Chassis producing In N11N30320ZNA589663 & Engine No. S324F44735 along with trolley (loaded with sand approx 60 CFT), Today on 26,08,2022 at about 09,45 hrs. acting on source information, I SI Subal Goswami of Arsha PS along with (i) C/-15 Sushanta Dey and (ii) HG- 1469 Ashok Kr. Mahato both of Arsha PS, Dist-Purulia, lest for PS area vide Spl. C.C No. 255 Dtd. 26.08.2022. After we reached at Bandu Bridge Ghat, near Aharrah morh under Arsha PS at 10.15 hrs, we conducted raid on the Bank of Bandu Bridge Ghat and found that 01 (one) tractor along with trolley attached with by a hinge was present at Bandu Bridge Ghat on the Bank of Bandu River near Aharrah morh. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Bandu River, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS.
