Sir,

In producing herewith the one accused persons namely Dulal Mandal (45 Yrs), S/O- Vikhulal Mandal of Vill- Kudlung, PS-Baghmundi, Dist-Purulia along with seized articles (1) 09 (Nine) liter ID Liquor containing in a white plastic jericin (2) 10 (Ten) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 31.07.2022 during my mobile duty as per source information, I SI Sudhir Kumar Mahato along with force 1. C/05 Biswajit Mahapatra. 2. C/1487 Tarani Sen Das both of Baghmundi P.S, Dist-Purulia reached at Kudlung village at about 17:55 hrs and found that the above noted person is selling I.D liquor in his house premises. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 18:05 hrs to 18:35 hrs I seized (1) 09 (Nine) liter ID Liquor containing in a white plastic jericin (2) 10 (Ten) Pcs Plastic Glasses from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 18:35 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Dulal Mandal (45 Yrs), S/O- Vikhulal Mandal of Vill- Kudlung, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
