On 17.08.2022 at about 11:20 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Sri Subhasis Mahato, Sr. OE, WBSEDCL, entered the premises of Sri Paresh Chandra Kuri, S/O- Late- Bhisham Chandra Kuri of village Nowadih, P.O-Suisa, PS- Bagmundi, Dist- Purulia and found Sri Paresh Chandra Kuri was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 1.30 KVA. As Sri Paresh Chandra Kuri, S/O- Late- Bhisham Chandra Kuri committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.
