I request you to take the necessary legal step against pradyut kumar Das Son of Late paresh Kr. Das, of Registry para, Balarampur on 22/8/2022 I went Balarampur P.S. for knowing about my case then came to know that no any case has been started hence I am sending this complain by Regd. post with A/D. on - 22/08/2022
