To The Officer-in-charge Bandwan Police Station, Dist- Purulia,

Sir.

In producing here with 03 (Three) arrested accused persons namely (1) Gambhir Majhi (27Y) S/O-Pashupati Majhi of Vill-Daha, PS-Manbazar, Dist-Purulia (2) Amar Majhi (22Y) S/O-Nilkamal Majhi of Vill-Baragari, PS-Bandwan, Dist-Purulia (3) Bulet Majhi (29Y) S/O-Falari Majhi of Vill-Geruala, PS-Kamalpur, Dist-East Singbhum, Jharkhand along with seized motor Cycle under proper seizure list, arrest memos & other relevant papers.

I beg to state that today (16.08.2022), in course of my mobile duty (vide Bandwan PS GDE No- 621, dtd 16.08.22) I had been to Chilla Mor at about 16:45 hrs and found that the three persons including driver with their Motor Cycle (Hero Splendor Plus) having number plate-WB-56T/5485 were roaming aimlessly near Chilla Mor by rough and negligence driving with triple riding. Myself along with force signed to stop them but the driver of the Motorcycle drove speedily and disobediently. We could be able to detain them at near Rimi Bypass Mor on Bandwan-Manbazar road (SH-5) under Bandwan PS area after a hot chasing. This rough and negligence driving would lead to an accident at any time. Being asked the above accused persons could not be able to give any satisfactory answer for that movement on road and public place by such rough driving.

So I arrested them for disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest. I informed them regarding the ground of arrest and arranged for informing their relatives. They were driving the motor cycle on public way in rash and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle.

So I seized Motor Cycle bearing number plate- WB-56T/5485 (Hero Splendor Plus) after preparing proper seizure list duly signed by the accused person and witnesses. All the process was done in between 16:45 hrs and 17:45 hrs.

So a specific case may be initiated against them as per law and arrange for its investigation.
