Sir,

In producing here with 02 (Two) arrested accused persons namely (1) Khagen Karmakar (23Y) S/O Jaladhar Karmakar of Vill-Hatnadih, P.O- Jiling, PS-Barabazar, Dist-Purulia (2) Ranjit Karmakar (23Y) S/O-Alahad Karmakar of Vill-Dhadkidih, P.O-Birra, PS-Patamda, Dist-East Singhbhum, Jharkhand along with seized motor Cycle under proper seizure list, arrest memos & other relevant papers.


I beg to state that today (21.08.2022), in course of my spl. mobile duty (vide Bandwan PS GDE No- 818, dtd 21.08.22) I had been to Bandwan - Barabazar bypass road at about 18:25 hrs and found that the two persons including driver with their Motor Cycle (Honda Shine SP 125) having number plate-JH-05CP/4311 were driving roughly recklessly near Bandwan - Barabazar bypass road. Myself along with force tried to stop them but the driver of the Motorcycle drove the vehicle at a high speed without paying least attention to us. We could be able to detain them at near Bandwan - Barabazar bypass road at a distance within a few minutes on Bandwan-Barabazar road under Bandwan PS area after a hot chasing. This rough and negligence driving may lead to an accident at any time. Being asked the above noted accused persons they could not be able to give any satisfactory answer for that recklessly driving on road and such public place.


So, I seized the above noted Motor cycle under proper seizure list duly signed by the accused persons and witnesses in between 18:35 hrs and 18:45 hrs.

I also arrested them for such rough and negligent driving maintaining all legal procedures regarding arrest, issued memo of arrest. I informed them regarding the ground of arrest and arranged for informing their relatives. On being asked they did not produce the valid documents in respect of said motor cycle. I offered them medical checkup but they denied took them to PS and kept in PS lock up maintaining all hazat procedures

So, I therefore request you that a specific case may be started against them under proper section of law and arrange for its investigation.
