Sub: Complain against Rampada Karmakar (age-22 yrs) S/O-Sunil Karmakar of Vill. Keshra Jamdih, P.S. Bandwan, Dist. Purulia to start a Cog case U/S 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with arrested accused person namely Rampada Karmakar (age-22 yrs) S/O-Sunil Karmakar of Vill. Keshra Jamdih, P.S. Bandwan, Dist. Purulia along with seized Illicit Distill liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 27/08/22 at about 16:45 hrs. I received a credible source information that one person namely Rampada Karmakar S/O-Sunil Karmakar of Vill. Keshra Jamdih, P.S. Bandwan, Dist. Purulia is preparing and stocking Illicit Distill liquor for selling without any valid license at his dwelling house at Vill. Keshra Jamdih, P.S. Bandwan, Dist. Purulia. Accordingly, myself along with evening patrolling duty officer force (PSI Suvajit Nandi, C/59 Alhad Rajak and C/1569 Mahendra Murmu all are of Bandwan P.S. Dist-Purulia) vide Bandwan P.S. C.C. No. 2859/22 Dtd: 27/08/22 left for Vill. Keshra Jamdih, as well as house of the Rampada Karmakar to work out the said source information. After reaching there at 17:05 hrs we held raid his house where the above mentioned person preparing and stocking Illicit liquor. During search with the help of accompany officer and force, we found that the said person is preparing and stocking Illicit Distill liquor for sell. Being asked, he disclosed that all liquor has been prepared/ stocked for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of preparing, stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses. One liter Illicit Distill liquor has been kept & labeled as sample bottle. Approx 10 liters Illicit Distill liquor has been seized. Then, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Rampada Karmakar (age-22 yrs) S/O-Sunil Karmakar of Vill. Keshra Jamdih, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
