Sub: Prayer for lodged FIR.

Sir,

In producing herewith arrested accused driver namely Buddheswar Mahato (32 Yrs) S/o- Sankar Mahato of Vill- Purihansa, PO- Roladih, PS- Barabazar, Dist- Purulia and one tractor attached with trolley, bearing Registration No- WB 55B 0492 loaded with approx 100 c.f.t sand along with all connected papers and seized articles.

I beg to state that on 09.08.2022 myself along with C/- 1182 Santosh Kr. Mahato and C/- 897 Umapada Dhalla were performing Day mobile duty vides Barabazar PS GDE No- 502 Dtd. 09.08.2022 with Govt vehicle. When we are going towards Takoria side on Barabazar Purulia pitch road near Bansbera morh under Barabazar PS at about 15.55 hrs found one tractor coming from Purihansa side towards Barabazar on Barabazar to Purulia pitch road. We stopped this tractor and apprehended the driver and found one tractor attached with trolley, bearing Registration No- WB 55B 0492 loaded with approx 100 c.f.t sand. I asked the driver to produce valid documents in respect of loaded sand. But the driver of said tractor failed to produce any valid documents before me.

Hence, I conveyed the same to I.C Barabazar PS over mobile phone and Seized the tractor attached with trolley loaded with sand about 100 c.f.t approx bearing Registration No- WB 55B 0492 under proper seizure list duly signed by witness. The seizure was made between 16.25 hrs and 16.45 hrs. I interrogated the alleged driver in detail and he confessed his guilt. Accordingly, I arrested the alleged driver namely Buddheswar Mahato (32 Yrs) S/o- Sankar Mahato of Vill- Purihansa, PO- Roladih, PS- Barabazar, Dist- Purulia after maintaining all formalities regarding arrest. Informed him regarding the ground of arrest and also informed his family members. The arrest was made at 16.55 hrs.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the Tractor collected the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting the sand illegally without any valid document in support of carrying sand.

Under the above facts and circumstances I therefore, pray before you that kindly take needful action against the arrested accused driver namely Buddheswar Mahato (32 Yrs) S/o- Sankar Mahato of Vill- Purihansa, PO- Roladih, PS- Barabazar, Dist- Purulia and owner of said tractor bearing Registration No- WB 55B/ 0492 for their such type of illegal act.
