Sub: Complaint against Subodh Rajak (37 Yrs) S/o- Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Subodh Rajak (37 Yrs) S/o-Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist-Purulia and seized one white colour Plastic Jarokin containing approx 17 (Seventeen) Liters I.D liquor on which 01 (one) liter taken as sample from said Jarokin as per enclosed seizure list.

I, ASI Sadhan Ch. Danda of Barabazar PS do here by lodge this complaint against Subodh Rajak (37 Yrs) S/o- Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist- Purulia. I beg to state that on 26.08.2022 myself along with C/- 1182 Santosh Kumar Mahato & C/- 347 Manas Kumar Pathak were left for mobile duty vides Barabazar PS GDE No- 1764 Dtd. 26.08.2022. During my mobile duty at about 17.25 hrs I received information that one person was selling liquor at Balaji morh (Taltal) near Bhagabandh village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 17.55 hrs myself along with force held a raid on that place and found that one person selling I.D Liquor. Seeing the Police party buyers fled away, but we apprehended the seller who was selling the Liquor. On search I found one white colour Plastic Jarokin containing approx 17 (Seventeen) Liters I.D liquor from his possession. On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors. On being asked he confessed his guilt and stated that he was selling the liquors I.D liquors from his house to the local peoples with intent to make his own profit. He disclosed his identity as Subodh Rajak (37 Yrs) S/o- Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors. Accordingly, I seized the above noted Liquor after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which one liter taken as sample from said Jarokin which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 18.05 hrs and 18.35 hrs. Thereafter, I arrested the accused person namely Subodh Rajak (37 Yrs) S/o- Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his family members regarding the grounds of arrest. The arrest was made on 26.08.2022 at 18.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Subodh Rajak (37 Yrs) S/o- Lt. Nikhil Rajak of Vill- Bhagabandh, PO- Rautora Bhagabandh, PS- Barabazar, Dist-Purulia under proper section of Law.
