

Sub: Prayer for lodged FIR,

Respected Sir,

In producing herewith one Tractor having Reg. No- WB55A-4378 with trolley loaded with approx 100 c.f.t sand, seizure lists, seized articles and arrested driver of said tractor.

I beg to state that on 02.08.2022 myself along with (i) C/1442 Shibsankar Singha, and (ii) C/1250 Jitendranath Dubey, were performing evening mobile duty vide Boro PS GDE No. 65 Dtd- 02.08.2022, C.C. No-2001/2022, Dtd: 02.08.2022, with Govt. vehicle Reg. No. WB55A-4378. When we were going towards Chalka village side and reached near Kallabera tola Pry. School of Chalka village under Boro PS at 17:45 hrs found one Tractor coming from chalka village sing para towards Khariduara Bridge more. I along with force rushed to the spot and found one Tractor having Reg. No- WB55A-4378 with trolley loaded with approx 100 c.f.t sand and standing beside the pitch road. I asked the driver valid papers in respect of sand which is loaded in the trolley. But he failed to produce any document.

Accordingly I seized the Tractor having Reg. No- WB55A-4378 with trolley loaded with approx 100 c.f.t sand, under proper seizure list which has been duly signed by witness. The seizure was done in between 18:05 hrs to 18:25 hrs on 02.08.2022 as well as I arrested the driver of sand loaded tractor namely Nirupada Saren S/O- Jagannath Saren of Vill- Chalka P.S. Boro Dist- Purulia.

I came to learnt that the driver was carrying sand the sand as illegally. It is assumed that driver and owner theft sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by removal of mines & minerals.

By this way they violated the regulation of procurement of sand. As such there is every reason to believe that the driver and owner of the said Tractor with ill motive were transporting the sand illegally **without any valid document** in support of carrying sand. He violated the Govt. orders. As such he was doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of sand loaded tractor.
