

Subject: Complaint against Mahadeb Saren (49 Yrs), S/O- Lt. Mathan Saren of Vill-Jagda, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Mahadeb Saren (49 Yrs), S/O- Lt. Mathan Saren of Vill-Jagda, PS - Boro, Dist - Purulia with seized 16 (Sixteen) sealed bottles in containing 300 ml each bottles styled as 'Bumpher' and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (14/08/2022) during my evening mobile duty in between 20:05 hrs to 20.55 hrs acting on a secret source information I apprehended the above noted person in his house at Jagda village and found that above noted person illegally stocked and selling Bumpher to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 16 (Sixteen) sealed bottles in containing 300 ml each bottles styled as 'Bumpher' and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 20.45 hrs u/s 46 A (C) B.E and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized 'Bumpher' country spirit 300 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Mahadeb Saren (49 Yrs), S/O- Lt. Mathan Saren of Vill-Jagda, PS -Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/253 Arabinda Mallik, (2) C/ 358 Ganesh Ch. Roy accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Mahadeb Saren (49 Yrs), S/O- Lt. Mathan Saren of Vill-Jagda, PS- Boro, Dist - Purulia.
