Sub:-Request for lodging F.I.R. against arrested accused driver Manoj Mahato (35 yrs.) S/O-late Kalipada Mahato of Vill- Keshyatard, PS- Hura Dist-Purulia, driver of vehicle No. JH02Z/6002

Sir,

In producing herewith arrested accused Manoj Mahato (35 yrs.) S/O-late Kalipada Mahato of Vill- Keshyatard, PS- Hura Dist-Purulia, along with seized vehicle No. JH02Z/6002 (Swift Dezire) I beg to submit that today on 31.07.2022 I SI Gopal Bhattacharyya along with C/330 Banamali Soren, C/2886 Anup Gorai and HG/1535 Pravas Ruhidas all of Hura PS were performing night mobile duty vide Hura PS C.C No - 1772/22 dtd. 31.07.2022 and while we crossed Madhuban village under Hura PS (Purulia-Bankura NH60A road) at about 20:15 hrs. we found one vehicle (Swift Dezire) having Registration No JH02Z/6002 was coming from Purulia side towards Hura side with rash and negligently and dashed road side drainage system. We rushed to the spot and found front side of the vehicle has been damaged but none injured. On being asked, driver of the said vehicle stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving. On demand he produced all Xerox documents in respect of the said vehicle and stated that original kept at home. Accordingly, I seized the above noted vehicle by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279/427 IPC. I also arrested driver of the said vehicle as he violated sec 279/427 IPC in presence of Police party. During the time of arrest maintained all formalities regarding arrest, issued memo of arrest and informed ground of arrest.

Hence I pray that a specific case U/S 279/427 IPC may kindly be initiated against accused driver Manoj Mahato (35 yrs.) S/O-late Kalipada Mahato of Vill- Keshyatard, PS- Hura Dist-Purulia and arrange its investigation.
