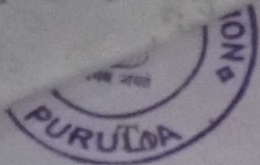

Sub:-Request for lodging F.I.R. against driver of vehicle No. WB56L/8146 and WB67B/6645

Sir,

In producing herewith seized vehicles No. WB56L/8146 (Maruti Celerio ZXI) and WB67B/6645(pickup van) I beg to submit that on 04.08.2022 I ASI Subhendu Mahato along with C/660 Arup Narh, C/330 Banamali Saren and NVF/908 Lakhindar Sing Mura all of Hura PS were performing night mobile duty vide Hura PS C.C No - 1805/22 dtd. 04.08.2022 and Hura PS GDE No-161dtd- 04.08.2022 and while we reached at Mangalpur village under Hura PS (Purulia-Bankura NH60A road) at about 21:45 hrs. we found one vehicle (Maruti Celerio ZXI) having Registration No WB56L/8146 was going to Purulia side from Hura side and another one (Pickup Van) having Registration No WB67B/6645 was coming from Purulia side towards Hura side with rash and negligently both the vehicle and hit directly. We rushed to the spot and found that front side of the vehicle (Maruti Celerio ZXI) has been damaged and front side of the pickup van has been scarring but none injured. On seeing police party both the drivers fled away. The accident occurred due to rash and negligent driving of the driver of both vehicles.

Accordingly, I seized the above noted vehicles by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute them U/S 279/427 IPC.

Hence I pray that a specific case U/S 279/427 IPC may kindly be initiated against both the drivers having Registration of vehicle No. WB56L/8146 and WB67B/6645 and arrange for its investigation.
