Sir,

In producing herewith two arrested accused namely 1. Jamal Ansary (60) S/O-LT Abdul Ansary of vill-Khairipihira, PS-Hura, Dist-Purulia 2. Ainul Ansary (60) S/O-LT Mosen Ali of Vill-Sukhlara, PS-Tamna, Dist-Purulia with Arrest Memo, seizure list, other related papers and seized articles such as 1. One head of tube well 2. Two handles of length 3 ft (approx) under proper seizure list and being labeled properly, I beg to inform you that today (19.08.2022) during my mobile duty under Hura PS area Vide Hura Ps CC No-1935/22 & GDE no-898 Dtd-19.08.222 with C/1348 Santanu Kapri, HG/1535 Pravash Ruidas, CD/1426 Sandip Mandal by Govt. vehicle bearing Reg. No-WB 56E/3101, received a telephonic information from my reliable source that one person has stolen some parts of govt. tube well from Bahukata village morh few days ago and today at about 15.30 hrs. he left for Madhuban More to sell the stolen articles at Scrap yard (kabari Khana). I informed the matter to OC Hura PS and as per his direction, acted on the source information and identified by him I along with force detained him at Kulgora morh and interrogated him and he disclosed his identity as noted above (Sl. No-1) and stated that he has stolen some parts of Govt. tube well and sold it to the owner of scrap yard namely Ainul Ansary (60) S/O-Lt Mosen Ali of Vill-Sukhlara, PS-Tamna, Dist-Purulia. Accordingly I held raid at the scrap yard at Madhuban morh with him at about 17.05 and recovered the stolen articles i.e. 1. One head of tube well 2. Two handles of length 3 ft (approx) from the possession of the owner of scrap yard. On demand he could not produced any papers in respect of the articles and from their statement there is every ground to believe that the articles has been stolen and the owner of the Scrap Yard has received the stolen property dishonestly knowing it to be stolen articles for his personnel gain. So, I seized the articles i.e. 1. One head of tube well 2. Two handles of length 3 ft (approx) after preparing proper seizure list and after seizure I arrested them maintaining all legal formalities regarding arrest as per the guidelines of NHRC, WBHRC and hon'ble APEX court of India. I also informed their relatives regarding their arrest.

Hence, I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
