In producing herewith seized vehicle bearing Reg. No. WB 67B/6817 (Mahindra Supro), I beg to submit that on 21.08.2022 I PSI Sk. Amanur along with JC/1499 Partha Mandal, HG/1449 Mithun Majhi all of Hura PS were performing day mobile duty vide Hura PS C.C No – 1955/22 dtd. 21.08.2022 and Hura PS GDE No- 989, dtd- 21.08.2022 and while we reached at near Madhuban morh under Hura PS (Purulia-Bankura NH60A road) at about 14.15 hrs. we found one vehicle having Registration No. WB 67B/6817 (Mahindra Supro) was going towards Purulia side with rash and negligently and hit a Milestone beside the road and overturned at the nearby field. We rushed to the spot and found that back side of the said vehicle has been damaged but none injured. On seeing police party the drivers fled away. The accident occurred due to rash and negligent driving of the driver of the said vehicle.
