

Sub: - Prayer for lodging FIR.

Sir,

I, SI Bablu Ghosh of Hura PS do hereby lodged this FIR against arrested accd persons (i) Yasin Khan (23) S/o Md. Ukil Khan of Vill- Sekhbigha, P.O- Sonnagar, PS- Barun, Dist-Aurangabad (ii) Nehal Kuraishi (24) S/o Jubber Kuraishi of Ward No- 31, Khalashi Moholla, PS- Model, Dist- Buxar (iii) Miraj Kuraishi(22) S/O- Murtaza Kuraishi of Vill- Vikramganj, P.S-Vikramganj, Dist-Rohtas all of state Bihar to the effect that on 22.08.22 during night mobile duty vide Hura PS GDE No- 1047 dtd- 22.08.2022 on Purulia-Bankura road (23.08.2022) morning around 05:30 hrs I, received a telephonic information from a reliable person that the one container labeled as "Amul Dudh" having Reg. No.- UP80BT-3021 loaded with cows going towards Bankura with high speed, with rash & negligently has been capsized at Bishpuria beside Purulia-Bankura (NH60A) road. After receiving information, I along with force rushed to the spot at about 06:00 hrs. and found one white colour container styled as "Amul Dudh" having Reg. No .-UP80BT-3021 capsized loaded with cows . I arranged to rescued the cows from the vehicle with the help of local people and found total twenty two (22) No's of cows was loaded on the said vehicle from which five No's of cows expired at the spot, six no's of cows injured and others eleven No's of cows injured mildly. The incident was occurred due to rash & negligent driving of the driver. Total three persons were on the vehicle including the driver. On being asked, they revealed their identity as noted above (SL no I as driver and Sl No 2 & 3 are his assistant) but their identities could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicle or the Cows, and about the procurement of the cattle or vehicle. Not only that they have not any paper regarding transportation of the cows etc. The vehicle is not meant for transporting livestock as no livestock permit was available. They have transported the cattle by concealing those cattle in a cruel manner which leads to the death of five cattle during this incident. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also

trying to conceal or disburse those cows for personal gain and they are habituated offender in such of offenses. Moreover, they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accd persons treated the cattle in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized those 17 Cows and the vehicle container styled as "Amul Dudh" having Reg. No.-UP80BT-3021 from 10:05 hrs to 10:35 hrs from the possessions of the above noted accd persons under proper seizure list where the description of each cow is mentioned and after seizure I also arrested them as thev committed offence U/S-379/411/413/414/120B/ 279/427/429 U/S-IPC 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accd persons, seized vehicle container styled as "Amul Dudh" having Reg. No. - UP80BT-3021 and the seized cows to PS. Due to accident frontal portion of the vehicle and one road side board has been also partly damaged. I also arranged postmortem of the died five cows by the concern authority. There was every reason to believe that this truck having Amul Milk advertisement on both sides of container was illegally transporting cattle from other states for the purpose of illegal inter-state cattle smuggling. The vehicle is not meant for transporting the cattle also.

I, therefore pray that a case may kindly be started against the arrested accused persons (i) Yasin Khan (23) S/o Md. Ukil Khan of Vill- Sekhbigha, P.O- Sonnagar, PS- Barun, Dist- Aurangabad ((ii) Nehal Kuraishi (24) S/o Jubber Kuraishi of Ward No- 31, Khalashi Moholla, PS- Model, Dist- Buxar (iii) Miraj Kuraishi(22) S/O- Murtaza Kuraishi of Vill- Vikramganj, P.S- Vikramganj, Dist- Rohtas all of state Bihar and (iv) Owner of the vehicle Reg. No.- UP80BT-3021(v)Owner of the Cows and others U/S-379/411/413/414/120B/279/427/429 IPC and U/S- 11(1)(d) (e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
