Sir,

In producing herewith seized vehicle bearing Reg. No. NL01AC/4531 (Trailer), I beg to submit that on 24.08.2022 I SI Gopal Bhattacharyya along with C/1335 Nirmal Kr. Mahato, C/1370 Satyendra Prasad Singh, CD/406 Md. Saiful Alam Ansary and NVF/264 Sanjoy Mahato all of Hura PS were performing night mobile duty vide Hura PS C.C No- 1974/22 dtd. 23.08.2022 and Hura PS GDE No-1083, dtd- 23.08.2022 and while we reached at near Pather sathi under Hura PS (Purulia-Bankura NH60A road) on 24.08.2022 at about 05:15 hrs. we found one vehicle having Registration No. NL01AC/4531 (Trailer), Engine No- 81G848C4625, Chassis No- MAT447264J5H20826 was going towards Bankura side with rash and negligently and overturned beside the road (Purulia-Bankura NH60A road) at Shamukgoria under Hura PS. We rushed to the spot and found that the parts of body of the said vehicle has been damaged but none injured. On seeing police party the drivers fled away. The accident occurred due to rash and negligent driving of the driver of the

Accordingly, I seized the above noted vehicle by preparing seizure list said vehicle. (details are mentioned in the attached seizure list) with a view to prosecute

Hence I pray that a specific case U/S 279/427 IPC may kindly be initiated against the driver of vehicle bearing Reg. No. NL01AC/4531 (Trailer) and arrange for its investigation.
